Public Hearing on Proposed Maximum Property Tax Dollars for Certain Levies for Fiscal Year 2023

Mayor Behnken opened the Public Hearing at 5:07pm.

Mayor Behnken reviewed the proposed Maximum Property Tax Dollars for Certain Levies ("Max Levy") with the Council, noting that the "Max Levy" applies to certain individual levies that the City uses that are part, but not all, of the overall tax levy for the City. The maximum amount that will be levied for Fiscal Year 2023 is for the following levies only: Regular General; Liability, Property & Self Insurance Costs; Emergency; FICA & IPERS; and Other Employee Benefits. The proposed Maximum Tax Rate totals \$12.78929. In addition to these levies, the City also utilizes the Debt Service Levy which is not included in the State's "Max Levy" requirements.

There being no written comments on file and no comments to be heard, Mayor Behnken closed the Public Hearing at 5:08pm.

Motion by Bradley, seconded by Schmitt to adopt R-025-2022 Resolution Approving the Maximum Property Tax Dollars for Budget Year July 1, 2022 through June 30, 2023. Motion carried, all ayes.

Motion by Scherbring, seconded by Bradley to set March 28, 2022 at 5:00pm as the date and time for a Public Hearing on the proposed budget for Fiscal Year 2023. Motion carried, all ayes.

#### Little Lending Library Request

The Council reviewed a request from Sophia Osmun to install a Little Library in the City's right-of-way adjacent to her parent's property on Winslow Drive as part of a Girl Scout project she is working on. City Manager Vick asked that if the Council approves the request, the base be made of a breakaway material in case a vehicle comes in contact with it. Vick further noted that if repairs are needed in the right-of-way, the library may have to be removed.

Motion by Poynor, seconded by Sherman to approve the request of Sophia Osmun to install a Little Library in the right-of-way at 115 Winslow Drive with the condition that the base be made of a breakaway material and the understanding that it may need to be removed if repairs are needed in the right-of-way. Motion carried, all ayes.

# **Holiday Decoration Replacement**

Motion by Scherbring, seconded by Sherman to approve the quote from Display Sales in the amount of \$11,332.00 to replace 27 of the City's holiday street light decorations. Motion carried, all ayes.

## Airport Land Acquisition Project

Motion by Poynor, seconded by Scherbring to adopt R-026-2022 Resolution Approving Amendment #1 with Kirkham Michael for the Airport Land Acquisition Project. Motion carried, all ayes.

### Utility Billing Folder/Inserter Proposal
