Public Hearing on the Request of Joe Dittrick to rezone 508 East Delaware Street from R1-60 (Single Family Low Density District) to C-2 Community Commercial District

Mayor Behnken opened the Public Hearing on the rezoning request at 5:11pm.

Jason Chapman, 505 East Main Street, addressed the Council regarding the rezoning request, stating his opposition to the rezoning of the property.

The Council discussed the rezoning request. City Manager Vick noted that the Planning & Zoning Commission had reviewed the request and did not recommend approval.

There being no further comments to be heard and no written comments on file, Mayor Behnken closed the Public Hearing at 5:16pm.

The Council discussed how to proceed.

Motion by Poynor, seconded by Bradley to proceed with the first consideration and adoption of Ordinance 001-2023 An Ordinance Amending the Official Zoning Map of the City of Manchester, Iowa (Rezone 508 East Delaware Street). On call of roll: Ayes: None. Nays: Poynor, Bradley, Sherman, Scherbring, Schmitt. The ordinance failed.

Public Hearing on the Request of R & J Rentals LLC to rezone Parcel 641323001900 on South Third Street from AG (Agricultural/Urban Reserve District) to I-2 Heavy Industrial District

Mayor Behnken opened the Public Hearing on the rezoning request at 5:18pm.

The Council discussed the rezoning request. City Manager Vick noted that the Planning & Zoning Commission had reviewed the request and did recommend approval.

There being no comments to be heard and no written comments on file, Mayor Behnken closed the Public Hearing at 5:19pm.

Motion by Scherbring, seconded by Sherman to proceed with the first consideration and adoption of Ordinance 002-2023 An Ordinance Amending the Official Zoning Map of the City of Manchester, Iowa (Rezone South Third Street). Motion carried, all ayes.

Public Hearing on the Proposed Contract Documents and Estimated Costs for the Shelly Park Redevelopment Project

Mayor Behnken opened the Public Hearing at 5:20pm.

City Manager Vick reviewed the proposed project with the Council, noting that the City had received a grant for the project which would cover 75% of the cost.

There being no comments to be heard and no written comments on file, Mayor Behnken closed the Public Hearing at 5:22pm.

The Council discussed the handicap accessibility of the project, the plans for relocation of the existing gazebo, the timeline for the project, and the City match requirements.

Motion by Scherbring, seconded by Poynor to approve R-012-2023 Resolution Approving and Confirming Plans, Specifications, Form of Contract & Estimate of Cost for the Shelly Park Renovation/Redevelopment Project. Motion carried, all ayes.

The Council reviewed the bids received for the project. City Manager Vick noted that eight bids had been received. Eastern Iowa Excavating had submitted the low bid of \$281,261.25, which was \$47,367.25 under the architect's estimate.

Motion by Bradley, seconded by Sherman to approve R-013-2023 Resolution Awarding Contract for the Shelly Park Renovation/Redevelopment Project. Motion carried, all ayes.

Water Department Spare Well Controls for Wells 5, 7, 8

City Manager Vick informed the Council that Water Superintendent Chad Wulfekuhle would like to purchase spare well controls for wells 5, 7 and 8 as he is no longer able to swap controls between wells when one goes down. This equipment allows the water department to have a back-up in the event the equipment goes down.

Motion by Poynor, seconded by Schmitt to approve the estimate from Lange Tech in the amount of \$6,956.00 for spare well controls for wells 5, 7, and 8. Motion carried, all ayes.

Construction Project Updates

Sam Ertl, Fehr Graham, and Jason Wenger, Burrington Group, updated the Council on construction projects in the City.
