City Manager Vick informed the Council that ECIA (the grant administrator) has expressed some concerns with the bid packet for the project, primarily related to required federal language and shelter construction that were not included. ECIA has recommended re-bidding the project but City Staff have concerns due to the tight timeline for the project. City Manager Vick discussed with the Council options to consider for the project, the grant requirements for completion of the project, the contractor requirements, and the scope of the project. City Manager Vick will continue to investigate alternatives and update the Council at the next meeting.
