Motion by Dittrick, seconded by Scherbring to approve the closure of South Franklin Street from Main Street to Delaware Street on June 19, 2025 and directing City Staff to work with the Chamber on the timing of the closure. Review decision of the Board of Adjustment to approve the request of Larry Brunsman for the property at 131 East Acers Street for a variance to City Code Section 165.06(6.2) "R-1 Single Family Residential Districts, Site Development Regulations" to allow for a reduction of the side yard setback from 6.5 feet to 3 feet

City Manager Vick informed the City Council that the Board of Adjustment had considered a variance request from Larry Brunsman of 131 East Acers Street, seeking to reduce the required side yard setback from 6.5 feet to 3 feet. The Board voted 2-1 in favor of the request; however, it was later determined that a minimum of three affirmative votes is required to approve a variance. With only three members present at the meeting, the vote did not satisfy this requirement. As a result, City Staff is recommending that the matter be remanded to the Board of Adjustment for reconsideration and appropriate action.

Motion by Gray, seconded by Schmitt to remand back to the Board of Adjustment the variance request of Larry Brunsman for the property at 131 East Acers Street to allow for a reduction of the side yard setback from 6.5 feet to 3 feet.
