Review of draft Ordinance Amending Provisions Pertaining to the Police Department

City Manager Vick reviewed the draft ordinance with the City Council, noting the intent was to streamline city operations and ensure consistent oversight, by clarifying the relationship between the City Manager, Police Chief, and Police Department. It would bring the Police Department under the direct daily supervision of the City Manager, mirroring the management structure of all other city departments. The Mayor would still appoint and remove the Police Chief with City Council approval, but the City Manager's office would handle the day-to-day administrative functions, similar to the City Clerk, who is appointed by the Council but managed daily by the City Manager.
