ORDINANCE 005-2025 AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF MANCHESTER, IOWA, BY AMENDING PROVISIONS OF THE RENTAL HOUSING CODE PERTAINING TO INSECT INFESTATIONS

Krystle DeShaw, Delaware County Public Health, reviewed bedbug issues in the area, treatment challenges, and noted limited public health authority since bedbugs do not transmit disease. The Council discussed tenant rights, property owner responsibilities, and disposal of infested items. City Attorney Jim Peters recommended lease addendums and model ordinance language to assist property owners, with Council members supporting the approach and potential modifications.
