Recycling

All recyclables must be rinsed, clean and dry; cartons and boxes should be flattened and all materials should be placed loose into a container or clear bags. Please cover or hold back on rainy or windy days.

Garbage

LIMIT: 80 lbs of garbage per week, divided between 2-35 gallon garbage cans. Garbage must be placed into clear or white bags and tied shut.

EXTRA GARBAGE / REMODELING DEBRIS/LARGE ITEMS

It is your responsibility to contact the garbage hauler directly for pickup. This includes but is not limited to: appliances, electronics, computers, carpeting, drywall, tires, mattresses, etc.

Recycling & Garbage must be to the curb by 7:00am. Hauler will not return to pick up late set-outs. Your garbage will not be collected if it contains things that cannot be taken to the landfill or if you have more than the allotted amount.

CITY-WIDE CLEAN UP

The City of Manchester does not participate in city-wide clean up days.

COMPOST SITE & BRUSH DUMP

Located at 541 S Brewer Street. Open sun-up to sun-down. Please follow regulations posted at the site. Construction material, concrete, landscape materials and manure are not accepted.

CURBSIDE LEAF PICK UP

Designated dates are announced in the Spring and Fall.

CHRISTMAS TREE PICK UP

The City provides a free, one day, city-wide pick up for trees. Trees must be placed curbside by 7:00am. Please check with official new sources for date.

FREQUENTLY ASKED QUESTIONS

GARBAGE OR RECYCLING

GLASS is considered garbage.

CANS & METALS

- **Recycle:** tin, aluminum or steel cans & lids
- **Garbage:** paint or aerosol cans, aluminum foil/food tins, pesticide/chemical containers, utensils, tools, pots and pans, hardware, car parts and oil filters

PAPER, CARTONS & BOXES

- **Recycle:** cardboard, newspapers, magazines, catalogs, phone books, mail, boxes
- **Garbage:** waxed paper & liners, dairy cartons, photos, crayon drawings, wrapping paper, pet food or fertilizer bags, oil-soaked or dirty cardboard

PLASTICS

- **Recycle:** milk jugs, food containers, soap containers
- **Garbage:** unmarked plastics, film products, Styrofoam, "peanuts", bubble wrap, auto lubricant or antifreeze containers, cds, shopping bags, flower pots, hangars, medical supply containers and sharps, prescription pill bottles, toys

TEXTILES

- **Recycle:** NONE. Clean, gently used clothing may be donated to a local organization or charity
- **Garbage:** all soiled, torn, unusable clothing, shoes or bedding, stuffed animals, pillows, leather, nylon

BATTERIES

- **Recycle:** NONE. mercury, silver or lithium batteries, nickel cadmium and lead-acid batteries are considered hazardous waste are only accepted at the Dubuque Metropolitan Area Solid Waste Agency (DMASWA)
- **Garbage:** alkaline, non-rechargeable batteries

ANIMAL CONTROL

Dogs over the age of 10 weeks, living within the City Limits, must be licensed within 60 days of acquisition. Owner must provide proof of rabies vaccination. Obtained from the City Office. Cost is \$20 for each neutered dog and \$50 for each unneutered dog. The City of Manchester does not license cats. Animal control/nuisance issues are handled by the Manchester Police Department.

ALTERNATE SIDE PARKING

Upon declaration, residents are required to park on the even-numbered side of streets on even-numbered days, and on the odd-numbered side of streets on odd-numbered days. Alternate Side Parking is only in effect from 10pm—7am. Parking on Snow Routes is prohibited. Ticketing and towing are STRICTLY enforced.

BUILDING & CONSTRUCTION

Before starting a construction project, be sure to contact the Building Official/Zoning Administrator to see if a permit is required. Call before you dig. Iowa One Call. 800.292.8989.

CURFEW LAW

Minors ages 16 & 17: 11pm Sunday-Thursday. 12 Midnight Friday & Saturday. Minors under age 16: 10pm Sunday-Thursday. 11pm Friday & Saturday.

FIRE PROTECTION & PUBLIC SAFETY

- Outdoor Warning Sirens are tested the first Wednesday of every month.
- Fireworks are illegal in the State of Iowa.
- Open Burning of yard waste, landscape debris or refuse is not allowed. Recreational fire pits are allowed for cooking, heating or recreation.
- Animal Control issues should be reported to the Manchester Police Department.
- Nuisance and property maintenance concerns should be reported to the Building Official.
- RUOK (Are You Okay) is a computer-based welfare check. Contact the Police Department for more information.

HOUSING PROGRAMS/TAX ABATEMENT

Housing programs are subject to change. Please contact E.C.I.A. at 800.942.4648. Tax Abatement applications are available at City Hall.

PARK SHELTERS OR SEIBERT HALL RESERVATIONS

Reserve a park shelter or Seibert Hall by contacting the City Office. Alcohol is not allowed on City property.

PARKS & REC PROGRAMS

The Leisure Guide is available at City Hall. Swimming lesson and summer registrations generally begin in April. Recreation programs are offered year-round for young and old!

PUBLIC WORKS MAINTENANCE

Please report potholes, water leaks, defective sidewalks, sewer and storm water backups, vandalism, or other public works issues to the City Office or to the Police Department (outside of normal working hours).

SIDEWALKS

Snow must be removed from sidewalks within 10 daylight hours after a snowfall.

TREES

Please contact the City Office for a permit to plant or remove a tree. Diseased/dying/dangerous trees should be reported to the City Office.

WINTER WEATHER & SNOW REMOVAL

- Snow must be removed from sidewalks within 10 daylight hours after a snowfall.
- Snow-filled driveways often result from clearing streets. This is unavoidable due to the nature of the snow removal process. The City does not clean driveways.
- Mailbox damage can be a casualty of winter. Please contact the City Office to report any suspected damage from snow removal equipment.
